DEMAND FOR INVESTIGATION AND SUSPENSION OF THE MEDICAL DIRECTOR OF THE FEDERAL MEDICAL CENTRE (FMC), ABEOKUTA, OGUN STATE; PROF. ADEWALE MUSA-OLOMU PENDING THE CONCLUSION OF INVESTIGATION

I write in respect of the above subject matter.

Human and Environmental Development Agenda (HEDA) Resource Centre, a leading Anti-Corruption Organization in Nigeria is a Non-Governmental Organization (NGO) and Non-partisan Human Rights and Development league. It has the mandate to protect and promote universally recognized human rights, accountability and environmental justice in Nigeria and Africa, in accordance with International standards. These objectives are pursued through research and publications, campaigns, human rights education and empowerment projects and programmes.

A report by the Punch Newspaper dated the 4th day of June 2021, made a handful of corruption allegations against the Medical Director of the Federal Medical Centre, Abeokuta. These allegations ranges from corruption, abuse of office, purchase of a refurbished CT scan at the price of a new one, age falsification, employment without due process amongst others.

On the 5th day of November 2021, newtelegraphng.com also reported that a group; All Youths Reoriented Initiative of Nigeria (AYRION) instituted a case with suit number: FHC/AB/FMC/100/21 at the Federal High Court, Abeokuta against the Medical Director of the Federal Medical Centre (FMC), Abeokuta, Ogun State; Prof. Adewale Musa-Olomu over alleged age falsification, mismanagement of funds, employed his biological son and within a year of employment, granted him study leave in a European country with pay.²

The account and asset of the Federal Medical Centre, Abeokuta were audited by the Auditing Firm of Jubril Olawale Lawal & Co. and Adeleye, Adeleye & Co. and a report dated June 2021, addressed to the Chairman, Hospital Management Board, Federal Medical Centre, Idi-aba,

Abeokuta, Ogun State was submitted. The audit report revealed quite a lot of misappropriation of funds and corruption. Kindly find attached, a copy of the audit report dated June 2021.

Going by our mandate as a leading Anti-Corruption organization in Nigeria, we demand that the allegations against Prof. Adewale Musa-Olomu be diligently investigated and pending the outcome of the investigation, Prof. Adewale be suspended from office in order to allow for a hitch free investigation.

Kindly take notice that we will closely monitor the situation and if no action is taking, we will not hesitate to take further actions including but not limited to litigation, media briefing among others.

Kindly accept our warm regard as we look forward to your action on this and a positive change in governance.
